Eighth Annual Memorial Day Run

May 23-25, 2008

Registration deadline: April 26, 2008

This poker run is sponsored by the Central South Dakota HOG Club.

Friday: Approximately 441 miles. – Start at Petersen Motors. First card drawn here. We will travel east on Hwy 14 to Hwy 281, North on 281 to Hwy 28, Hwy 28 East to Hwy 25, stay on Hwy 25, it will become Hwy 18 in North Dakota and junction up with Hwy 13, East on Hwy 13 to Wahpeton/Breckenridge. You can take the 210 bypass around Wahpeton/Breckenridge or you can go through town, your choice. Take Hwy 210 to I-94, I-94 North to Hwy 59 to Detroit Lakes. At Detroit Lakes take Hwy 34 all the way to Walker, Minnesota. Motel selection is AmericInn, Lakeview Inn, and Country Inn & Suites. Second card will be drawn here.

Saturday: Approximately 349 miles. Take Hwy 200 east out of Walker to Hwy 2. Follow Hwy 2 to Superior, Wisconsin. Be sure to stay on Hwy 2 East to get to Hwy 35 South. Follow Hwy 35 South to junction of Hwy 63. (If you want, when you get to Hudson, you can take Road F south out of Hudson and it will junction up with Hwy 35 South near Prescott. This road follows the river more closely.) Take Hwy 63 to cross river into Red Wing, Minnesota, and then follow Hwy 63/61 to Wabasha, Minnesota. AmericInn is where the third and fourth cards will be drawn.

Sunday: Approximately 289 miles. – From Wabasha, stay on Hwy 61 to I90, on I90 go east to junction of Hwy 16, Hwy 16 West to I90, follow I90 to Jackson. At Jackson, Minnesota, take Hwy 71 south to Okoboji. We are staying at the Arrowwood Resort & Conference Center. Fifth and bonus cards will be drawn here. Bonus Card – On Hwy 16 at Hokah, take Hwy 44 south to Caledonia, and return to Hwy 156 on Hwy 76. Purchase a pop, gas, candy bar, souvenir, or something at Caledonia. Each participant with a poker hand must have his/her own receipt as proof they were in Caledonia. This receipt must be presented at the final stop to be able to draw a bonus card.

Monday: You are on your own, have a safe trip home!!

This is a fun ride. We travel through some beautiful country. This year will be more trees and river than mountains. However, there is still the possibility of seeing plenty of wild life, either on the ride or at the hotel in the evenings when the riders are “relaxing.” Bring extra film and warm clothes, these rides can be cool over Memorial Day.

We will leave Pierre on Wednesday evening July 2nd from Petersen Motors at 6:00 p.m. and ride to Bismarck, North Dakota. Riders may leave earlier if so desired. Will sign release forms at motel in Bismarck Thursday morning. From Bismarck we will travel to Williston, North Dakota, and then on to Malta, Montana, for the evening. Friday leave Malta and ride to St. Mary, Montana, for 4th of July fireworks. Saturday will leave St. Mary via Going to the Sun highway to Logan pass. Stopping at Logan Pass for pictures, etc. continue on to Helena, Montana, for the evening. Sunday morning leave Helena and ride to Broadus, Montana, for the evening. Monday leave Broadus and arrive home in Pierre.
