

NEW Moped Decal Order Form



Code of Virginia: §46.2-915 **Stickers required on mopeds.** Any dealer who sells any moped at retail shall affix to any such moped, or verify that there is affixed thereto a permanent decal or sticker which states among other things that (i) the operation of mopeds on highways and public vehicular areas by persons under the age of 16 is prohibited by Virginia law, (ii) the maximum engine size, and (iii) the maximum speed (35 mph) at which the moped may be ridden.

Any dealer who sells any such moped which does not have affixed thereto such a permanent decal or sticker, shall be guilty of a Class 1 misdemeanor.

Warning

Virginia law (§46.2 - 914 and 915) permits operation of this vehicle as a moped or motorscooter only:
 1. On highways or public vehicular areas by persons age 16 or older.
 2. At speeds not to exceed 35 mph.
 3. As long as operator carries identification including name, date of birth and home address.
This engine does not exceed 50 cc.

Violation of these and other moped provisions may result in a fine.
